

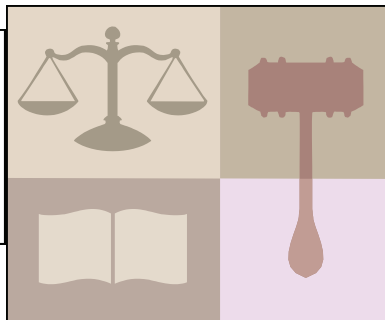

If you are not a panel member yet, the LRS is an excellent way to build a new practice or increase your business for an affordable price.

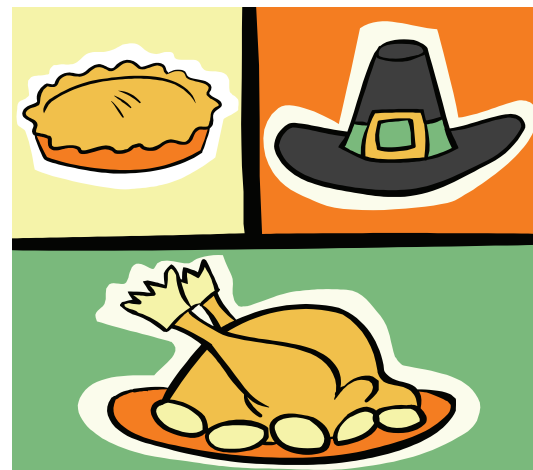
While there are openings for Criminal, Personal Injury, Fam-
