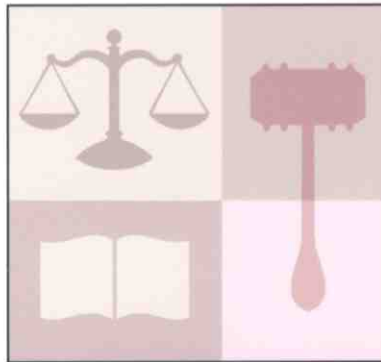

Judge Crispo began his legal career in 1961 after graduating from Loyola Law School with the Los Angeles City Attorney's Office. He started solo practice in 1962 and by 1967 was a partner of Breidenback, Swainston, Crispo and Way. He was elevated to the Los Angeles Superior Court in 1994 where he remained until he retired from the bench in 2004. His experience is in both Civil and Criminal Courts and has handled diverse cases including: business, civil rights, commercial, computer fraud, construction, eminent domain, employment, entertainment, family law, governmental liability, insurance coverage, bad faith, intellectual property, malpractice, personal injury, product liability, real estate, securities and toxic tort. He has had extensive work on judicial committees. As a lawyer, he has had professional associations with ABOTA, American Inns of Court,
