during the 2014 Spring Meeting of the College in La Quinta, CA.

Founded in 1950, the College is composed of the best of the trial bar from the United States and Canada.

Fellowship in the College is extended by invitation only and only after careful

investigation, to those experienced trial lawyers who have

mastered the art of advocacy and whose professional careers have been marked by the highest standards of ethical conduct,

professionalism, civility and collegiality. Lawyers much have a minimum of fifteen years trial experience before they can be considered for

Fellowship. Membership in the College cannot exceed one percent of the total lawyer population of any state or province. There are currently approximately 5,789 members in the United States and Canada, including

active Fellows, Emeritus Fellows, Judicial Fellows (those who ascended to the bench after their induction) and Honorary Fellows. The College strives to improve and elevate the standards of trial practice, the administration of justice and the ethics of the trial profession. Qualified lawyers are called to Fellowship in the College from all branches of trial practice. They are carefully selected from among those who customarily represent plaintiffs in civil cases and those who customarily represent defendants, those who prosecute individuals accused of crime and those who defend them. The College is thus able to speak with a balanced voice on important issues affecting the legal profession and the administrative of justice.

State Bar Updates

Nominations sought for the 2014 Benjamin Aranda III Access to Justice Award: The California Commission on Access to Justice is seeking nominations of California judges for the 2014 Benjamin Aranda III Access to Justice Award. The deadline is **May 30**. The Aranda award recognizes one California trial judge, appellate court justice or commissioner for his or her efforts to improve access to the judicial system. Recipients have demonstrated a long-term commitment to equal access to the courts and have done significant work in improving access to the courts for low and moderate income Californians. Proposed Amendment to calculation of proportional MCLE requirements: This agenda item requests a 45-day public comment period for a proposed amendment to the calculation of proportional MCLE requirements due for attorneys who were not on Active status and not otherwise exempt for the full 36 months of their MCLE compliance period. The current formula for calculating a proportional requirement, as provided on the State Bar's website as a "Proportional Requirement Table", automatically eliminates the usual one hour of required "Elimination of Bias" credit and the one hour of required "Prevention, Detection and Treatment of Substance Abuse or Mental Illness" credit in cases where less than the full 25-hour MCLE requirement applies. The proposed amendment would keep these required hours intact within every member's requirement, regardless of the pro-rated total number of hours due.

Requesting Authorization to send Attachment A to US News & World Report: The Council on Access & Fairness (COAF) initiated dialogue in 2008 with U.S. News & World Report (U.S. News) to encourage the addition of diversity as a factor in the overall law school rankings. After various opportunities for additional dialogue, U.S. News has responded that it has no plans to consider including diversity as a factor in its rankings. COAF asks the Stakeholder Relations Committee to recommend that the full Board of Trustees authorize COAF to send the attached letter to U.S. News. The letter summarizes the dialogue and U.S. News' final decision on diversity. Following the sending of this letter, COAF will re-focus its efforts to address the barriers to law school admissions for diverse students.

MCLE Providers Audit Program Policies: Before the policies and procedures are finalized, however, Board of Trustees' action on two policy issues is being sought. It is recommended that the Board of Trustees adopt policies that would permit MCLE auditors to receive personal MCLE credit for programs they attend on behalf of the State Bar of California and as a general Board policy, Board of Trustees members not participate as auditors.

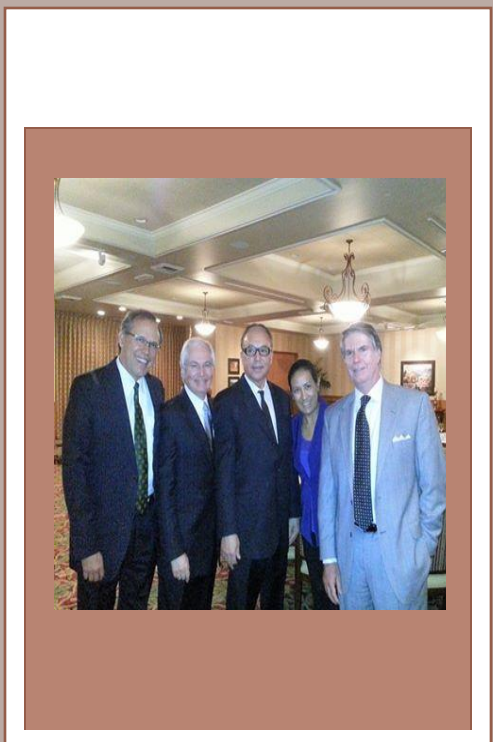
